- 1. Our child is not suffering from any infection/congenital disease or/and other illness and ailment. If our child develops any disease, illness or ailment including asthma or allergies, but excluding common cold and influenza, at any time during enrollment at the school, we shall promptly inform the Academic Head/Class Teacher of the same and will ensure that our child does not attend the school till such infection, illness or ailment continues.
- 2. We have been informed that in the course of the activities carried on at the school our child will use toys, educational tools, apparatus and equipment that will be provided and made available by the school. However, we are aware that the use of toys, educational tools, apparatus and equipment involve certain hazards and risks, and we grant specific consent to the school for allowing our child the use of such toys, educational tools, apparatus and equipment.
- 3. We are also aware that in the course of interacting and playing with other children in the school, and generally in the course of time spent at the school, our child may get hurt or injured keeping in mind the spirited and adventurous nature of the children generally and otherwise.
- 4. We understand that field trips and picnics are an integral part of school activities and while the school will take every measure to ensure the safety of the students, we shall not hold the school responsible for any unfore-seen injury/accident.
- 5. Non-vegetarian food/food products are strictly prohibited within school premises. The school management's decision on the food served within school premises will be final.
- 6. We will abide by all the rules and the regulations of the school as given in the prospectus, notices etc. and will follow the instructions as and when issued by the Academic Head/School from time to time.
- 7. We will deposit the school fees on or before the prescribed date. In case of non-compliance, at the end of 30 days, the name of the student will be stuck-off from the school's register. We understand that after this, it would be treated as a new admission.
- 8. The Leaving/Transfer Certificate will be issued only after all dues are settled.
- 9. We understand that one calendar month notice is to be given to the school in writing for a withdrawal by the parent or the legal guardian.
- 10. We agree to our child's photograph appearing in any brochures/publications of the school.
- 11. We confirm that we shall not claim or hold the school, its trustees, directors, teachers, staff, employees, instructors and/or agents liable or responsible in any manner whatsoever (whether by contract or otherwise howsoever), including for costs or expenses arising there from, for any injury or harm that may be caused to our child in the circumstances set out in clauses 2, 3, and 4 above.
